AS-228 Tryptic Soy Agar with Polysorbate 80 and Lecithin (TSA-TL)

INTENDED PURPOSE

TruPRASTM Anaerobic Culture Media is intended for the transport, preservation, or cultivation of a wide variety of microorganisms from specimens to aid in the isolation of bacteria for in vitro diagnostic and / or research / general laboratory purposes.

INTENDED USERS

Scientists, laboratory, and healthcare professionals trained in anaerobic microbiology techniques working in areas such as clinical, research, industrial, pharmaceutical and veterinary applications.

FORMULATION*

TSA-TL is an enriched, nonselective medium used for the growth of microorganisms, including yeasts and molds. The nutritive base consists of casein and soy peptones, while sodium chloride maintains osmotic balance. TSA-TL contains neutralizers polysorbate 80 and lecithin, which are commonly used to inactivate residual disinfectants during sample collection. Lecithin neutralizes quaternary ammonium compounds, and polysorbate 80 neutralizes substituted phenolic disinfectants. TSA-TL is suitable for use in environmental air sampling protocols. This medium is prepared, dispensed, and packaged under oxygen-free conditions using TruPRAS™ Technology to prevent the formation of oxidized products prior to use. This product is supplied ready to use, with no pre-reduction step required.

STORAGE AND SHELF LIFE

Storage: Upon receipt, store at room temperature $(15 - 25^{\circ}C)$ in original package until used. Avoid overheating or freezing. Do not use media if there are signs of deterioration (shrinking, cracking, or discoloration due to oxidation of media) or contamination. The expiration date applies to the product in its original packaging and stored as directed. Do not use product past the expiration date shown on the label.

Shelf Life: 6 months from the date of manufacture.

PROCEDURE

Specimen Collection: Protect specimens for anaerobic culture from oxygen during collection, transportation, and processing. Consult appropriate references for detailed instructions concerning collection and transportation of anaerobes. The selection of specimens for culture is made by physicians or scientists collecting the sample.

Methods for Use: Refer to the most recent editions of relevant reference materials for recommended procedures.

MATERIALS REQUIRED BUT NOT PROVIDED

Standard microbiological supplies and equipment such as loops, saline blanks, slides, staining supplies, microscope, incinerator / autoclave, incubators, anaerobic chamber / anaerobic jars, disinfectant, other culture media, and serological / biochemical reagents.

INTERPRETATION OF RESULTS

TSA-TL supports robust growth of a wide range of microorganisms, including yeasts and molds.

LIMITATIONS

TSA-TL does not provide complete information for the identification of microorganisms, including yeast and mold isolates. Additional test procedures and media are required for full identification. Additionally, this medium may not support the growth of all clinically significant anaerobes. Consult appropriate reference materials for further guidance.
